

# WARRANTY DISCLAIMER

## LIMITED LIFETIME WARRANTY

### **Nelson Cabinetry**

**hereby warrants to**  
the original residential purchaser

for residential applications only, that all cabinets and accessories, hinges, and drawers, including system hardware, are free from defects in materials and workmanship. This limited lifetime warranty runs for as long as the purchaser owns their home and begins upon the date of delivery. The purchaser is responsible for inspecting and accepting the product before installation, and by installing the product the purchaser indicates full acceptance. This warranty is expressly limited to the repair or replacement of the defective part at the discretion of Nelson Cabinetry and does not include labor for removal or replacement of any item or product otherwise covered by this warranty.

#### **What will Void the Warranty?**

This warranty is rendered void if the product has been subjected to improper handling, storage, installation, assembly or disassembly, intentional damage, product modifications, accidental misuse, abuse, negligence, force majeure, or normal wear and tear, or if it has been exposed to the elements, including humidity, which may result in warping or splitting. This warranty does not cover incorrect drawer and door alignment resulting from cabinets that are installed out of level, square, or plumb. Improper care, such as neglect of chips and scratches, water damage, or appliance damage, voids the warranty.

#### **Natural Variations**

Natural woods may vary in texture, color, and wood grain, and they may exhibit subtle changes as they age. For example, wood joints may eventually develop visible cracking around the joint area and cabinet colors may darken or lighten over time. Sunlight, smoke, moisture, household cleaners, and other environmental conditions may cause materials to vary from their original color and/or to warp, split, or crack. These variations are considered to result from the natural characteristics of wood and are not covered under this warranty. If your product has been discontinued, Nelson Cabinetry reserves the right to provide a replacement product that best approximates the wood, style, and color of your original purchase.

#### **Additional Limitations and Disclaimers**

Nelson Cabinetry makes no other warranties other than those set forth herein and all other warranties are hereby disclaimed. The implied warranties of merchantability and fitness for a particular purpose are limited in duration to the length of the limited warranty period. The limited warranties set forth herein are limited to the first and original buyer and are not transferable to subsequent owners.

Failure by the purchaser to produce proof of purchase voids any claims made under this limited lifetime warranty. In no event shall Nelson Cabinetry be liable for incidental or consequential damages to the purchaser or to any third party, including, without limitation, damages arising from personal injury, lost profits, loss of business opportunity, loss of property, economic losses, or statutory or exemplary damages, whether from negligence, warranty, strict liability, or otherwise.
